Executive Director Report for 2021-2022

2021-2022 was a year of rebuilding and reimagining for Silverheights Neighbourhood Association. We started off slow and small when reintroducing in person programs to our community, keeping safety our number one priority. We reached out through surveys and emails asking our community what they wanted and what they were comfortable with, and we continued to engage with our community to let them know we were still here for them.

The first part of our year was spent reintroducing our programs in a new COVID friendly manner, which meant outside for most of them. It was fun to see the kids all running around in their outdoor gear playing noodle tag or active running games, just happy to be back and connecting with peers. This was also the time we started our youth council with a group of 5 teenagers who wanted to make a difference in their community. It was so great to see them connecting over zoom each week brainstorming safe initiatives they could do to make a difference in their community. They held lots of community clean ups, a food drive, took part in the CNO notes of hope campaign and were great at handing out, door knockers to let their neighbours know there is a neighbourhood association right in their community. Over the last few months our youth council has grown to 15 youth, and we are so excited to see what lies ahead for this group.

The second part of the year was spent adapting to our ever-changing environment. Programs were running but still in an outdoor capacity. We held our pop ups at the parks allowing 106 youth to engage in outdoor recreation activities and some STEAM programming. We still had our virtual summer camp allowing 34 families who still were not quite ready to join the in-person programming still have their youth engaged and connected throughout the summer. We continued to have our LIT/youth volunteer program allowing 126 youth to engage in their community throughout the year. We had 4 COVID friendly events allowing 515 participants connect with us throughout the year and we have been so happy to welcome everyone back, old, and new.

This year with the help of the Lyle Hallman foundation, we also partnered with Greenway Chaplin Community Centre and Preston Heights Community Group on a few collaborative projects. Some of these included our Community Cuts program allowing children to receive back to school haircuts with local small barbers and hairdressers in our neighbourhoods. We also ran a fall pumpkin event together and a virtual family day event together. Our collaboration has allowed us to mentor staff and students in various areas of learning. It has allowed us to create new opportunities for our community members and create a bigger community for all who live in our areas.

One of our biggest challenges this year has continued to been space as we are in a school. We understood the reasons why we could not be up and running right away, but it was hard as some of the community members were ready to come back and get involved again. We really appreciated their patience with us as we continued to navigate through this. I am forever grateful for the support, flexibility and understanding from our funders and partners. It has been instrumental in the rebuilding

of Silverheights Neighbourhood this past year. It has allowed us to reopen to in person in a safe and consistent manner.

Thank you to the Silverheights Neighbourhood Association's staff for their dedication and support to our children and youth. Thank you to our Board of Directors for the time they dedicate to support the staff, organization, and community. Please know you are making a difference and we appreciate all you do. Thank you to the community for participating in and attending our programs and events. We are so grateful to you all!


