Land Acknowledgment



SNA is located on the Haldimand Tract within the territory of the Neutral, Anishnaabe and Haudenosaunee peoples. The Haldimand Tract is land granted to the Haudenosaunee of the Six Nations of the Grand River by Sir Frederick Haldimand, Captain General and Governor in Chief of Quebec & Territory in 1784. The Haldimand Treaty promised land 6 miles out along the Grant River to Six Nations for land lost in the United States as a result of their alliance to the British. Today, less than 5% of the Haldimand Tract is Six Nations of the Grant River's lands. As a result, litigations are ongoing between the Six Nations of the Grand River and the Crowns of Canda and Ontario for compensations. We recognize the SNA runs programs and camps, and builds community on lands that were promised to the Six Nations of the Grand River. SNA encourages our staff, volunteers and community to continue to learn the history of the land we live, work and play on. Community Engagement Report for 2023-2024

Since our last AGM, SNA has continued to be supported by a strong group of youth volunteers. Together they volunteered over 1487 hours in summer camp, youth council, events and year-round programs. With the addition of older adult programs at SNA, our adult volunteer base grew as well - together they volunteered over 415 hours.

Over 2023 and 2024, we have focused on expanding our leadership opportunities for youth by hosting more youth trainings for no and low cost in the neighbourhood. Trainings includes resume workshops, Safe at Home, Babysitters training, and High Five: Principles of Healthy Development certification.

SNA's youth council continues to be made up of a small group of engaged youth who meet weekly to create youth teambuilding activities, and civic engagement projects in the neighbourhood. Highlights from this year include leading another Notes of Hope project in collaboration with SNA's girls group, a City of Cambridge Youth Award nomination, and a trip to Niagara Falls with Preston Heights Community Group's youth leadership group.

This summer we are grateful for the 26 LIT volunteers that helped to support our summer camp. We are also grateful to the 4 youth engagement volunteers that volunteered weekly throughout the summer to take care of St. Gabriel Catholic School's vegetable garden and to run Freezie Friday handouts.

Thank you to our volunteers for all the ways you support SNA and partner with us to give back to your Silverheights neighbourhood.

Programming Report for 2023-2024

SNA was excited to offer a variety of youth and older adult programs, events, and workshops this year. We had a successful year of registered programs with over 70 participants and 488 visits. Registered programs included Active Club, STEM, Art Club, Cooking club, and About the Bounce, which was a specialty program that offered a combination of leadership development and basketball training. Our Drop-In programs were also popular through out the last year with over 1200 visits to our Drop-In STEM and Open Gym nights. SNA has made an effort to incorporate leadership elements into our programs over the last year, such as in our About the Bounce Program, as well as our Girls Leadership program that we were excited to introduce in the spring of 2024. We are excited to keep moving forward with these leadership initiatives as they have been a highlight of the last year.





Older Adult programs were introduced in the last year with our most popular program being the Older Adult Computer Workshop Series. We consistently had 3-4 participants attend the workshop series.

During December of 2023 SNA offered an a new shopping care program, that allowed parents to drop their children off for a few hours during the evening while they completed their holiday shopping. This had 36 Children registered over a total of 6 evenings. Other events included the prom outfit event, which helped provide local youth with free formalwear for their prom and end of school events. We also held our annual Neighbourhood Day in June and heldd a variety of junior and family nights, where we had activities such as pumpkin carving and winter photo backdrops. In total we were able to have over **400 community members in attendance at our events throughout 2023/4.**

A huge thank you to all of our program staff and volunteers who have contributed their time and effort over the past year and have allowed us to continue serving our community!

Camp Report for 2023-2024

In 2023, we were excited to offer many full day camps to our community to help create everlasting memories for their children. Camps in 2023 was a great success with both **Summer and March Break having over 350**registrations. We were able to employ 9 summer staff with the Canada Summer Jobs funding. In the beginning of 2024, we were able to run Get Out and Play half day programs in January which filled up with 30 participants throughout the sessions. In 2024, the numbers for our camp programs have been increasing selling out almost every week this year.
